Residents and Businesses:

**Effective April 4, 2007**, the Regional Income Tax Agency (RITA) has been collecting municipal income tax for the Village of Bettsville. RITA is a non-profit governmental agency established in 1971 under chapter 167 of the Ohio Revised Code and is the largest municipal income tax collection agency in the State of Ohio. The Village of Bettsville chose the Regional Income Tax Agency for its ability to offer residents and businesses eFiling, ePayment capabilities and to maximize the Village's tax collection efforts. RITA will be responsible for the administration and collection of all income taxes and will serve as an Agent of the Village of Bettsville in this capacity.

All Village of Bettsville tax payments and tax forms, for **current and prior tax years**, are to be sent to RITA. We encourage you to utilize RITA's electronic filing and payment system as it is fast and simple to use, and it is secure.

Checks or money orders should be payable to the Regional Income Tax Agency or RITA. Please include your Account Number as indicated above on all payments and correspondence.

**Village of Bettsville residents** will receive a 2018 individual post card filing reminder by the end of January 2019. **Business accounts** will receive 2019 Withholding forms and a 2018 Net Profit postcard filing reminder by the end of January 2019.

If you have an existing account with RITA and are already remitting withholding taxes for another RITA municipality, simply add the Bettsville withholding tax payment to the RITA Form 11.
